## STALLION SERVICE CONTRACT

I, \_\_\_\_\_ (mare owner), hereby agree on \_\_\_\_\_ (date) to contract with Tien Quarter Horses (Breeder) and BOXO Quarter Horses (Stallion Owner) to breed the following mare, \_\_\_\_\_ (mare name) Reg.No.: \_\_\_\_\_ to the stallion **OPUS CAT OLENA (AQHA #5617906)** for the 2026 breeding season subject to the following terms & conditions:

The 2026 Breeding Fee for **OPUS CAT OLENA** is **\$1500** (includes first shipment)

- **\$500** Booking Fee—*Non-Refundable and due with completed contract.*
- **\$1000** Balance of Breeding Fee—*Due when mare is dropped off or ten (10) days before semen will be shipped.*
- **\$250** Chute Fee- *Due when mare is dropped off or ten (10) days before semen will be shipped*
- **\$250** Cooled Semen Shipping Fee—*Due before additional each shipment!*
- **\$350** Frozen Semen Shipping Fee— *Due before additional each shipment!*

### ONSITE

- Mare Owner acknowledges that the Breeding Fee must be paid in full when mare is dropped off.
- Mare Owner agrees to pay Breeder for mare board and care. The 2026 charges for board are twelve dollars (\$12) for dry mares and fourteen (\$14) for wet mares, each calendar day. If special arrangements are needed for board, those charges will be discussed. All vet, farrier, vaccinations, deworming and any other charges related to care of mare/foal will be the responsibility of Mare Owner.
- Mare Owner acknowledges that upon notification of Mare being bred and ovulated that Mare Owner has seven (7) days to pick up Mare. If Mare is not picked up within seven (7) days all daily board fees will double for each calendar day so forth.
- Mare Owner agrees to provide Breeder with a current negative coggins test, and health papers including proof of current vaccinations. Breeder recommends all mares are vaccinated for: Tetanus, EHV, Rhino, West Nile, Sleeping Sickness, and Strangles.
- Mares should be in healthy and sound breeding condition.
- Breeder reserves the right to refuse to accept any mare which is not in proper breeding condition and/or does not provide all records, tests and registrations documents required.
- Mare Owner acknowledges that the Chute Fee included with said Breeding Fee covers all standard procedures for two (2) cycles. If any additional services are required above standard procedures, they will be at the expense of the Mare Owner.
- Breeder agrees to diligently try to settle mare and shall have sole discretion of best method of breeding said mare. If, however, said mare does not settle, Breeder and/or Stallion Owner shall be held harmless.
- Mare Owner acknowledges that Breeder will provide care for mare (and foal) while in Breeder's possession, to prevent accident, sickness, injury or death and that Mare Owner will not hold Breeder, its owners, employees, the stallion owner, or any of their employees responsible if any such occurrences should arise. It is understood the Breeder, its owner, employees, veterinarians, and guests shall not be held liable for any injury, escape, disability, illness, or death of any horse on its premises whether from fire, flood, theft, act of God or any other reason.
- Mare Owner acknowledges that Breeder will use best judgement in providing care for mare and/or foal while in Breeders possession. Medical care will be administered if deemed necessary and all expenses associated with said care will be the responsibility of the Mare Owner.
- We reserve the right to fulfill this contract with frozen semen if necessary.

## COOLED SEMEN

- Mare Owner acknowledges the Breeding Fee must be paid in full before any shipment is sent.
- Breeding Fee includes the first shipment. Mare owner must pay \$250 for each additional shipment needed prior to any shipment is sent.
- Mare Owner is responsible for confirming breeding days and ordering their shipment 48 Hours prior to desired ship day. All orders need to be called into Kent (785.973.8288) or Ashlee (785.973.8287).
- Mare Owner is responsible to confirm shipment on shipping day by 9 AM CST. Cancellations will need to be made by 9 AM CST of shipping day to avoid being charged for the shipment.
- Shipments are sent in an Equine Express II container and are shipped via Fed-Ex Priority Overnight. Weekend shipments are not available.
- Mare Owner should expect ONE dose of semen/shipment. If two doses are available, they will be sent.
- Mares on the premises of the Breeder have priority on any given day, therefore, there is no guarantee that cooled semen is available on any given day. In event that there is insufficient semen available on breeding day, Breeder will ship on a first order, first serve basis.
- Mare Owner acknowledges that Breeder will make every attempt to deliver viable semen in good condition but once the shipment leaves, Breeder and/or Stallion Owner cannot be held liable for untimely delivery or condition of the semen.
- Mare Owner agrees to use cooled semen within 24 hours of receiving and shall only be used on said mare in this contract.
- Mare Owner agrees to return Equine Express II container to Breeder within 7 days. If Equine Express II container is not returned a \$40 replacement fee will be assessed.
- Breeder agrees to provide cooled semen as described above, but if said mare does not settle Breeder and/or Stallion Owner shall be held harmless.
- We reserve the right to fulfill this contract with frozen semen if necessary.

## FROZEN SEMEN

- Mare Owner acknowledges the Breeding Fee must be paid in full before any shipment is sent.
- Breeding Fee includes the first shipment. Mare owner must pay \$350 for each additional shipment needed prior to any shipment is sent.
- Each frozen shipment includes 8 straws, additional straws are available upon request for \$20 per straw.
- Mare Owner is responsible for ordering their shipment 48 Hours prior to desired ship day. All orders need to be called into Kent (785.973.8288) or Ashlee (785.973.8287).
- Mare Owner is responsible to confirm shipment on shipping day by 9 AM CST. Cancellations will need to be made by 9 AM CST of shipping day to avoid being charged for the shipment.
- Mare Owner should expect ONE dose of semen per shipment, which contains at least one (1) billion progressively motile sperm cells.
- Shipments are sent from **Nebraska Bull Service** (Shipper) via UPS/FedEx
- Mare owner agrees transfer shipment from shipping container to personal storage container upon arrival.
- Mare Owner understands that a return label will be included with the shipment and must be placed on container and ready for UPS/FedEx pick-up the **NEXT BUSINESS DAY**. Shipper automatically sends pickup notification to UPS/FedEx upon delivery.
- Mare Owner acknowledges that if they don't transfer shipment upon delivery that Shipper and/or Breeder is not responsible if shipment is damaged or returned.
- Mare Owner acknowledges that if shipping container is not returned, they are responsible for the full replacement value.
- Mare Owner acknowledges that Breeder, Stallion Owner, and Shipper will make every attempt to deliver viable semen in good condition but once the shipment leaves, Breeder, Stallion Owner and/or Shipper cannot be held liable for untimely delivery or condition of the semen.
- Mare Owner agrees to use the frozen semen on said mare in this contract.
- Breeder agrees to provide frozen semen as described above, but if said mare does not settle Breeder and/or Stallion Owner shall be held harmless.
- Any unused Frozen Semen is property of Breeder, and it must be returned to Breeder.

2. **Live Foal Guarantee:** A live foal is defined as a newborn foal that stands and nurses without assistance. If the mare is found open, aborts or foal is still born, Mare Owner will be issued a Rebreed Contract. Breeder must be notified within seven (7) days of occurrence for Rebreed to be valid. If Mare Owner sells said mare the live foal guarantee is terminated.
3. **Rebreeds:** If said mare does not produce a live foal the first breeding season, mare can return on a Rebreed Contract during the following year. Rebreed Contract are between BOXO Quarter Horses(Stallion Owner) and Mare Owner. If **OPUS CAT OLENA** is standing at Tien Quarter Horses, Mare Owner is responsible for the chute fee and any other expenses that may be incurred. If **OPUS CAT OLENA** is no longer standing at Tien Quarter horses, Mare Owner is responsible for making breeding arrangements with new breeding facility. Breeder is not responsible for any fees associated with a Rebreed Contract. If Mare Owner fails to return mare for breeding the following year; then all fees paid are forfeited, Rebreed Contract is terminated, and Breeder and Stallion Owner are released from all further obligations. All third year rebreeds are at sole discretion of Breeder and Stallion Owner.
4. **Embryo Transfer:** Mare Owner must note on the top of this contract if this contract is for Embryo Transfer. In event, that multiple embryos are retrieved from single flush, Mare Owner agrees to notify Breeder once the additional recipient mares have been confirmed in foal with heartbeat. Mare Owner must then pay an additional \$1500 Breeding Fee to Opus Cat Olena for each additional live foal. Additional Breeding Fee is due upon additional foal(s) standing and nursing. Additional Breeders Certificates will be issued when all additional Breeding Fees are paid.
5. Mare Owner agrees to provide Breeder with status of pregnancy within forty-five (45) days from the date of ovulation. Failure to contact Breeder by September 1<sup>st</sup> will result in \$50 late fee to add mare to the stallion breeding report.
6. This contract is valid for the 2026 breeding season only. If contract is not fulfilled during the 2026 breeding season, it will become a Rebreed Contract and will incur an additional \$250 chute fee and any additional stallion fee.
7. The 2026 Breeding Season begins February 15<sup>th</sup> and ends July 1<sup>st</sup>.
8. If Stallion dies, is sold, or is unfit for service, then this contract shall become null and both parties are relieved from any further obligation. All monies paid by Mare Owner will only be returned by discretion of Breeder and Stallion Owner.
9. If Mare dies or is deemed not sound for breeding, Mare Owner can provide a substitution. No monies will be returned
10. Mare Owner is responsible for contacting Breeder when a live foal is produced. A Breeder Certificate will be issued if all fees associated with said breeding are paid.
11. All fees associated with the care of mare and/or foal are due before they can leave Breeder. Mares/Foals staying longer than thirty (30) days will have invoices sent monthly. Payment is due on receipt of said invoice. All past due amounts are charged a 2% finance charge or the maximum allowable by law.
12. When Mare Owner signs and returns this contract it becomes binding from both parties. Contract must be completed in full and be accompanied with a copy of mare's registration papers.

This contract represents the entire agreement between the parties. No other agreements, promises or representations; verbal or implied; are included herein unless specifically stated in this agreement. This contract is made and entered into in the State of Kansas and shall be enforced and interpreted with the laws of said State. It is understood the Breeder and its owners, stallion owner, employees, veterinarians, and guests shall not be held liable for any injury, escape, disability, illness, or death of any horse on its premises whether from fire, flood, theft, act of God, or any other reason.
